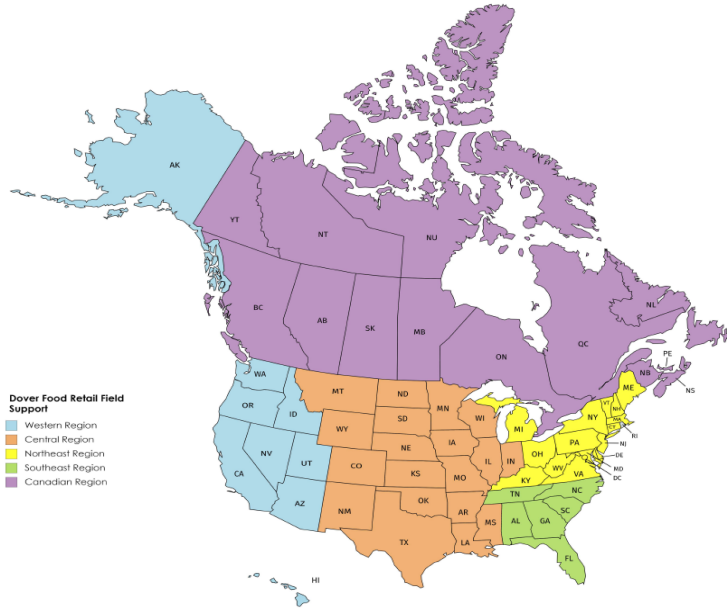


Dover Food Retail Field Support Regional Map
